Call to Order: Jennfier Raley called the meeting to order at 12:00 pm. The minutes were approved as submitted.

Clean Air Partners Updates: Jen Desimone

Jen introduced the following new members to the Board:

This fall we will be surveying residents on their perceptions and attitudes on regional air quality. Our Public Awareness survey is conducted every three years. The results are used to inform the development of future work programs and program initiatives and provide a mechanism to report success to program funders and sponsors. Through the RFP process, OpinionWorks was selected as the vendor – they have worked with Clean Air Partners on the past two surveys. This summer, the Marketing Committee finalized the questionnaire, which will be released this month. The Board can expect to see results in early 2025.

2024 Summer Campaign: Kenna Swift, Sherry Matthews

Sherry Matthews provided a recap on the 2024 summer initiatives that included the following.

• Air Quality Awareness Week & Gas-Powered Lawn Tool Exchange – Held the backyard bubble/lawn tool exchange. Held 3 events at ACE Hardware stores, including 6 days of exchanges of 150 electric tools.

Results include over 204,000 impressions, over 13,000 engagements, 16 news stories, and over \$9 million in publicity value.

- Owned Social Content Included posts on Facebook, Instagram, Twitter/X, and NextDoor and newsletter mailing resulting in nearly 30,000 impressions and 13,000 engagements.
- Partner Engagement 19 partners shared or engaged with Clean Air Partners content.
- Ozone Action Month Included pop-up, eco-driving event, and media pitching. Partnered with Commuter Connections to promote Car Free Day. Results include over 2,000 impressions, 1,300 engagements, and 200 Car Free Day pledges.

Regional Tree Planting Initiatives: Kelsey Sisko, MDE and Kenna Swift, Sherry Matthews

MDE and Clean Air Partners staff provided an update on regional tree planting initiatives. The tree plantings will take place in environmental justice communities.

MDE Tree Planting – Partnering with the Baltimore Tree Trust, the tree planting will take place in November in the Curtis Bay community (along high truck traffic areas and adjacent to the CSX coal terminal). There will also be an open community event in Curtis Bay Park.

Clean Air Partners Tree Plantings – Partnering with Casey Tress on two tree planting events during October, including one in Hyattsville (October 12) and one in DC (October 5). Forty trees will be planted at each event. Events will also include outreach incorporating air quality messaging in flyers, emails, infocards, and event registration sites. Planning is also underway for a Baltimore event that will take place during spring 2025.

Other Business:

Bob Erdman, EVADC, announced that National Drive Electric Week is September 27 – October 6. The first event in the Washington region is Saturday, September 21, in Poolesville, MD.
